The purpose of the corporation is to engage in the following business activities:

 charitable, scientific, or educational within the meaning of section 501(C)
 (3) of the Internal Revenue Code of 1986 (the "Code"), as amended from time
 to time, and shall, as its primary activity, initiate fund raising through
 donations, grants, or other means to provide funding for the preservation,
 restoration, and continued maintenance on historical buildings, structures
 and objects by any means so chosen that places it under protective care,
 within the perimeter of the Town of Granby, Massachusetts.

ARTICLE III

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:
